## Faculty Development Programme



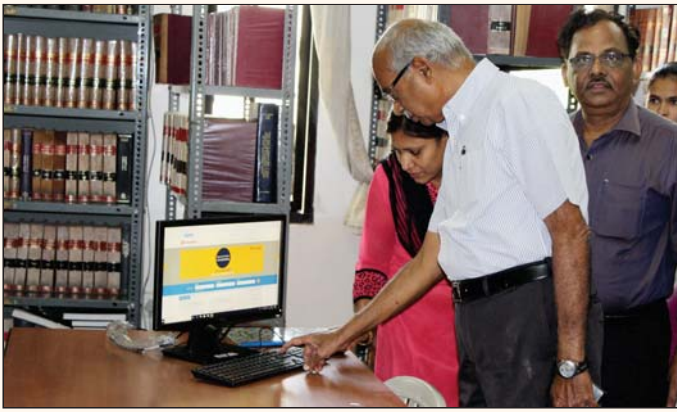

## Library and Knowledge Repository

Recently the college has subscribed to Manupatra Legal Database, for facilitating research in law for the students that helps the students, to update themselves with the latest case law and other developments through legislative and judicial process. ### Seminar, Conferences & Special Lectures

1. Sri G. Vasanth Kumar, DSP, CID, delivered a guest lecture on 'Investigation of Criminal Cases' on 30.03.2017, which helped the students to come across the practical aspects of the criminal investigation, charge sheet, discharge, pre trial procedure.
2. On 14.10.17 & 15.10.17, a Two-Day Telangana State Level Seminar on 'Consumer Law – Redressal Mechanism and Recent Developments', was organized by Pendekanti Law College and Consumer Chair, NALSAR University of Law, Hyderabad. The theme of the seminar was to throw light on various aspects of consumer justice and its dynamics in India,



to fulfill the constitutional mandate of ensuring justice, the working of the consumer disputes redressal mechanisms and contribution of consumer organizations, NGOs, Civil Societies, professional organizations, Industrial bodies and research institutions to the Consumerism in India. The occasion was graced by the dignitaries from bar, bench, faculty members and research scholars from various fields.

3. On 25.11.2017 Sri. T.V. Madhusudhan, Former **Deputy Controller of Patents**, Chennai, delivered a lecture on 'Patent Filing and Prosecution' . The lecture emphasized on various steps and time periods involved from the filing date of the application for patents till the grant of patent to the applicant.
4. On 21-12-2017, Ms. Swathi, Asst. Professor, **Dept. of Psychology, O.U.**, addressed the students on 'Psychology and its relevance to the legal profession'. In this context, she categorically explained the need of study of Psychology by law students and legal

### Mooters of the Year



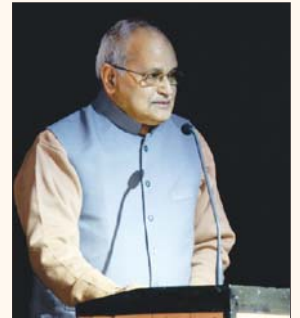
The College selected and nominated nine students to participate in national moot court competitions conducted by different law colleges across the country.
