**Instructions for Authors**

**1. Submission Categories**

The Journal accepts the following types of submissions:

- **Articles:** 6,000–8,000 words.
- **Short Articles :** 3000-5000 Words.

## 2. Originality and Plagiarism

- Submissions must be **original and unpublished** and should not be under consideration elsewhere.
- All submissions will be screened for plagiarism. Manuscripts exceeding the acceptable similarity will be rejected.

## 3. Structure of the Article

All submissions must adhere to the following structure to ensure uniformity and facilitate the peer-review process:

- **Title**

The title should be concise and clearly indicate the central argument or legal issue addressed in the manuscript.

- **Abstract**

An abstract of **250–300 words** outlining the background, research problem, objectives, methodology (where applicable), key arguments, and conclusions of the paper.

- **Keywords**

Authors must provide **4 to 6** relevant keywords immediately following the abstract.

- **Introduction**

The introduction should contextualize the research problem, highlight its legal and constitutional significance, state the research questions and objectives, and briefly outline the structure of the article.

- **Literature Review / Theoretical Framework** (*if applicable*)

A critical review of existing literature, legal theories, and scholarly debates relevant to the subject matter.

- **Research Methodology** (*if applicable*)

A clear description of the research approach adopted, including doctrinal, comparative, empirical, or interdisciplinary methods.

- **Analysis and Discussion**

The main body of the article, comprising a detailed legal analysis supported by statutes, case law, policy documents, and comparative or international perspectives. This section should be divided into coherent headings and sub-headings.

- **Findings / Observations** (*if applicable*)

A concise presentation of key findings emerging from the analysis, particularly in empirical or comparative studies.

- **Critical Evaluation**

Original analysis and critique of existing legal frameworks, identifying limitations, implications, and emerging challenges.

- **Conclusion**

A summary of the principal arguments and conclusions, addressing the research questions posed.

- **Recommendations / Future Directions** (*If applicable*)

Suggestions for legal reform, policy development, or future research.

- **References**

All sources must be cited through **footnotes only**,

#### **4. Formatting Guidelines**

- Manuscripts should be submitted in **MS Word (.doc/.docx)** format.
- Font: **Times New Roman**, Size **12** (main text), **10** (footnotes).
- Line spacing: **1.5** for text; **single-spaced** footnotes.
- Margins: **1 inch on all sides**.

#### **5. Citation Style**

- Submissions must strictly follow the “**Bluebook: A Uniform System of Citation 21<sup>st</sup> Edition**” citation style.
- Footnotes should be used for citations and endnotes are not permitted.

#### **6. Peer Review Process**

- The Journal follows a Blind **peer review** process.
- Authors must ensure that their manuscript does not contain any identifying information, including name, affiliation, acknowledgments, or self-referencing clues.
- A separate cover page containing the author’s name, institutional affiliation, contact details(email id), and a brief bio (100–150 words) must be submitted.

- The Editorial Board reserves the right to make **minor editorial changes** for clarity, consistency, and formatting without altering the substance of the submission.
- Substantive changes, if required, will be communicated to the author.
